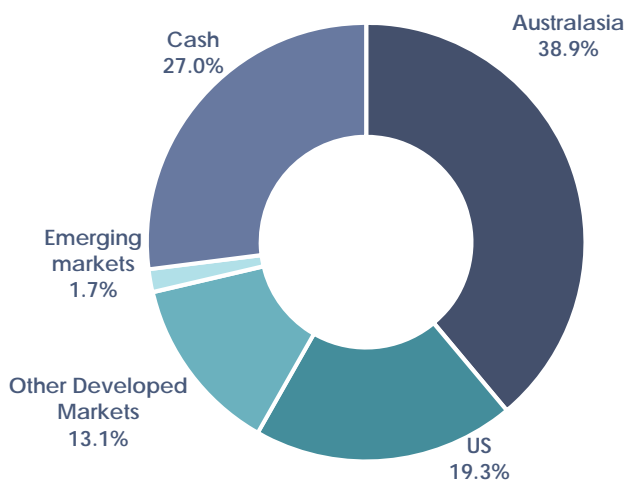

## REGIONAL EXPOSURE



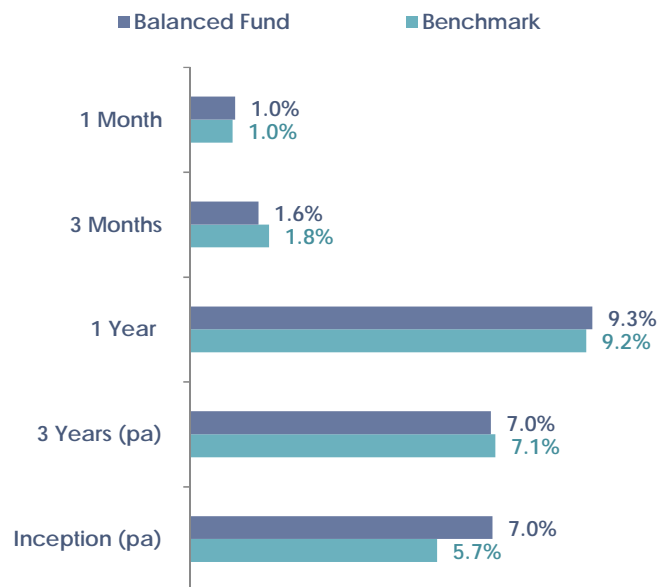
