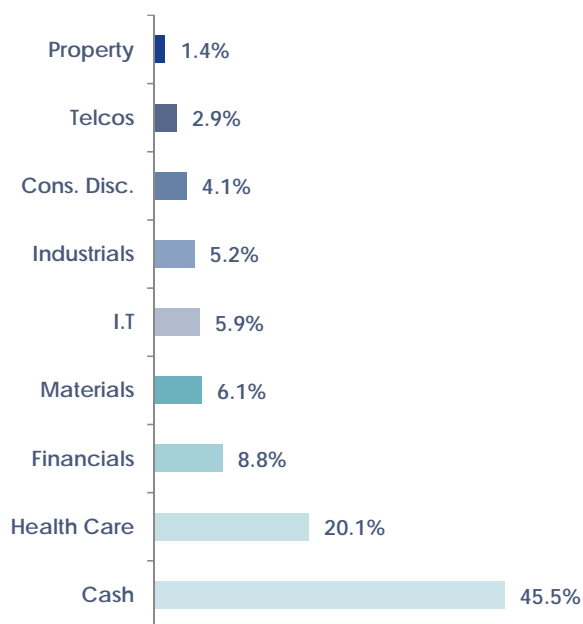
## FUND DESCRIPTION

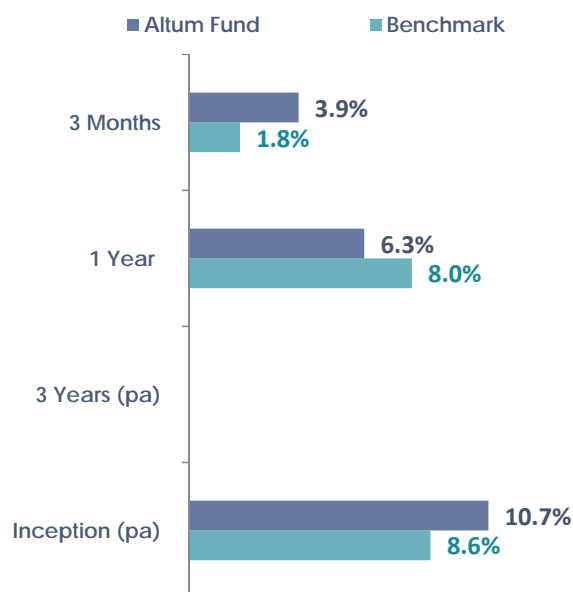

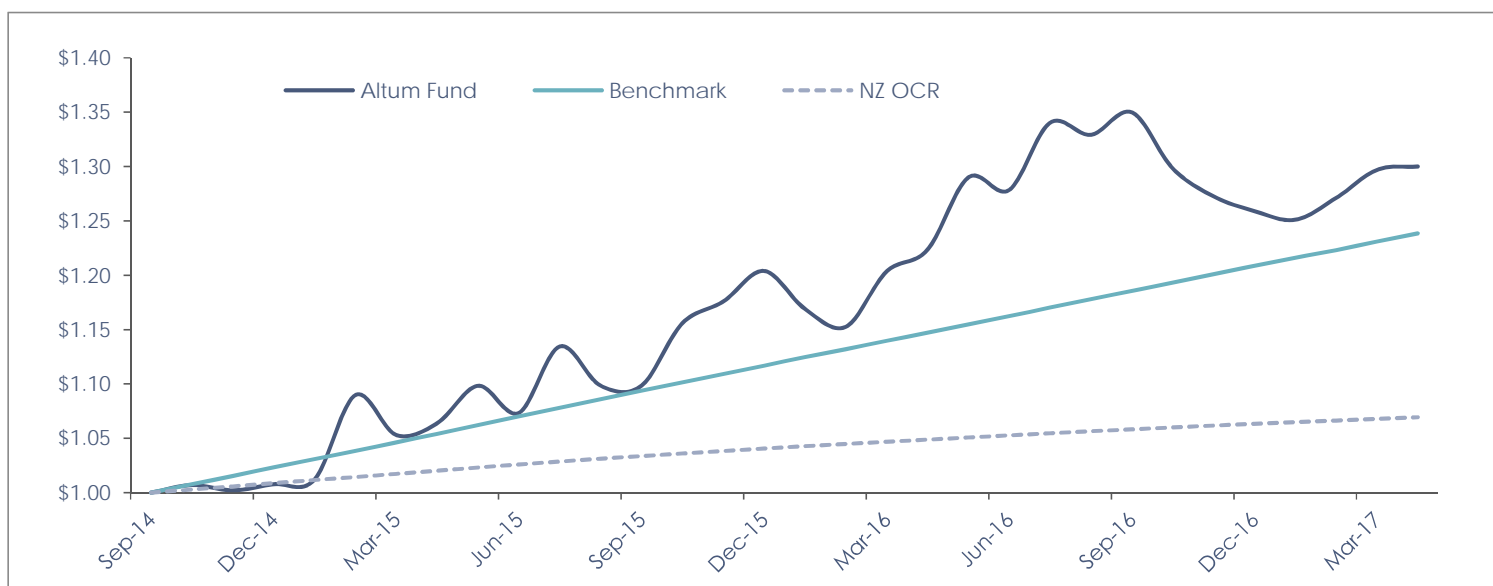
