FUND DESCRIPTION

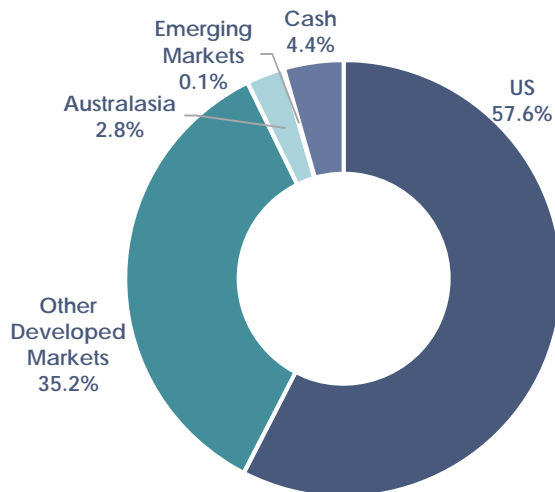

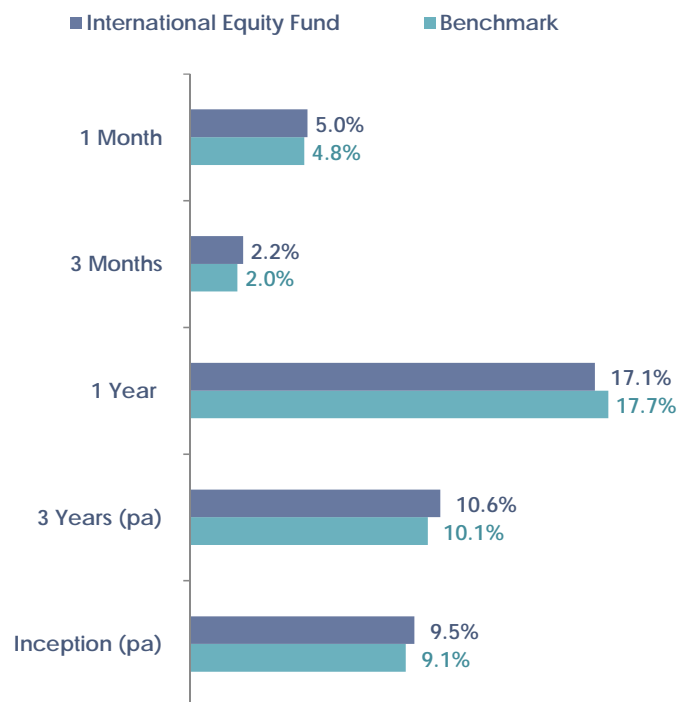

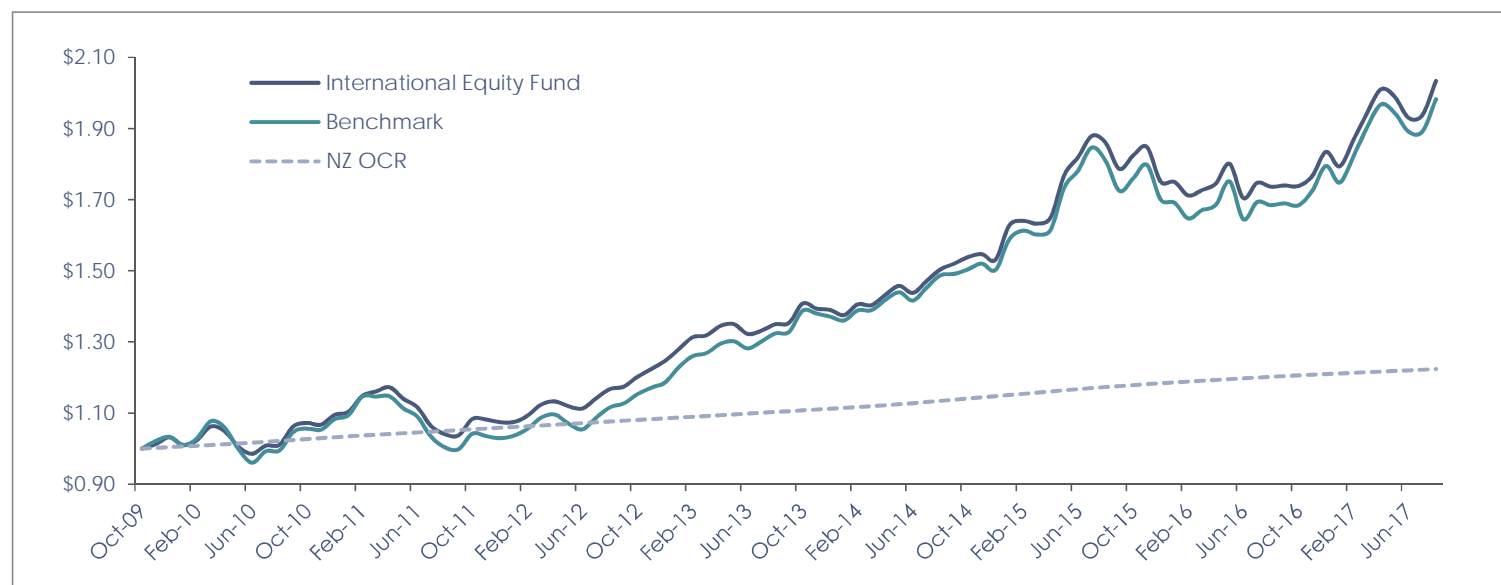
