FUND DESCRIPTION

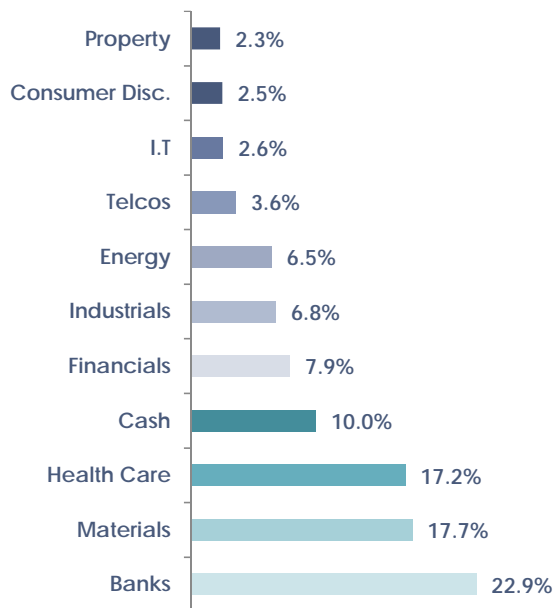

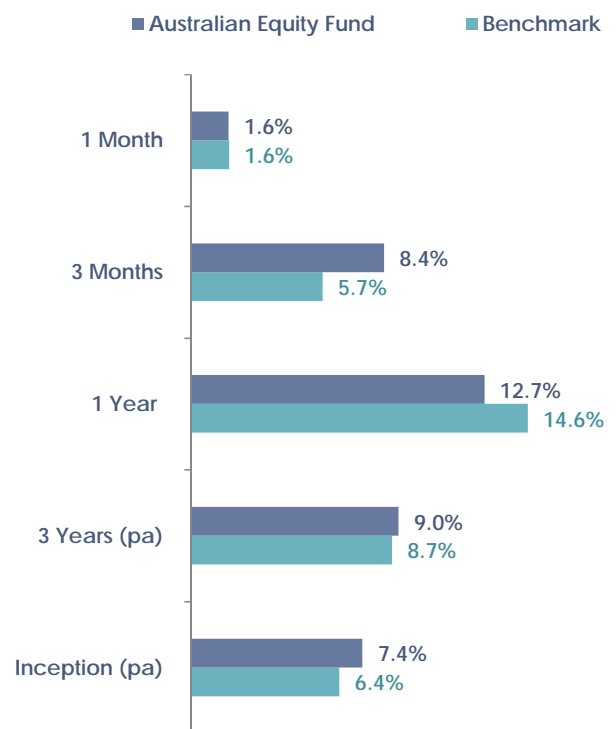

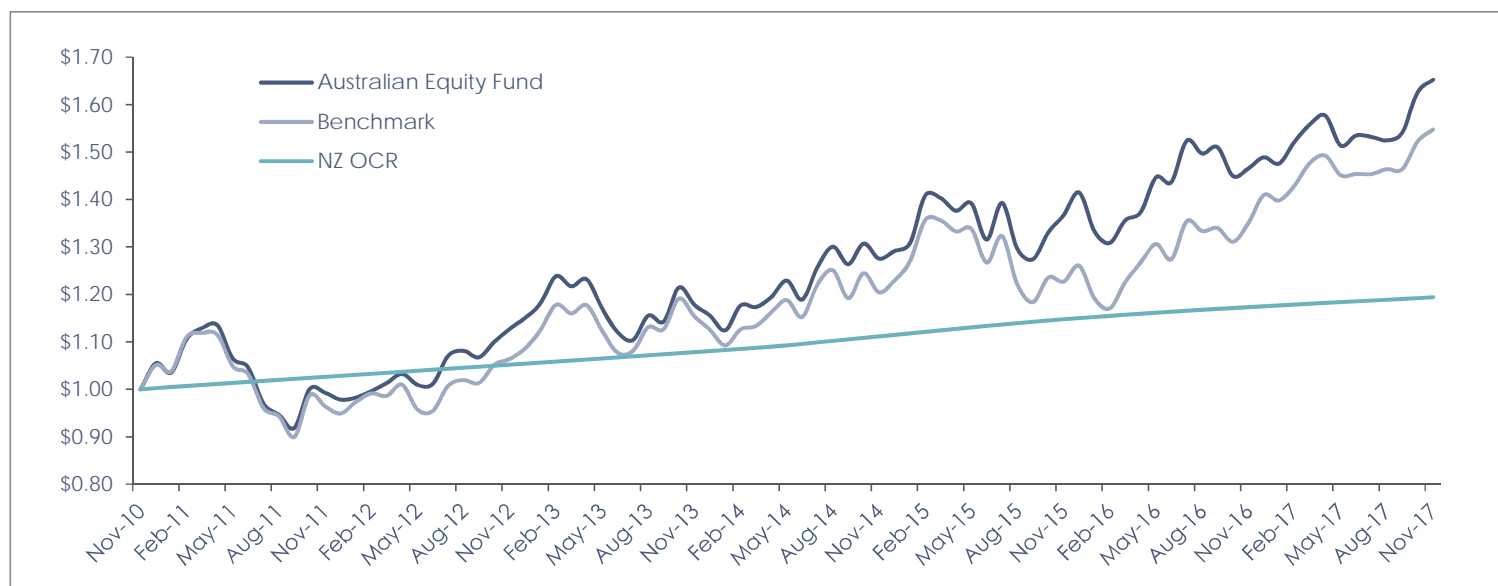
