FUND DESCRIPTION

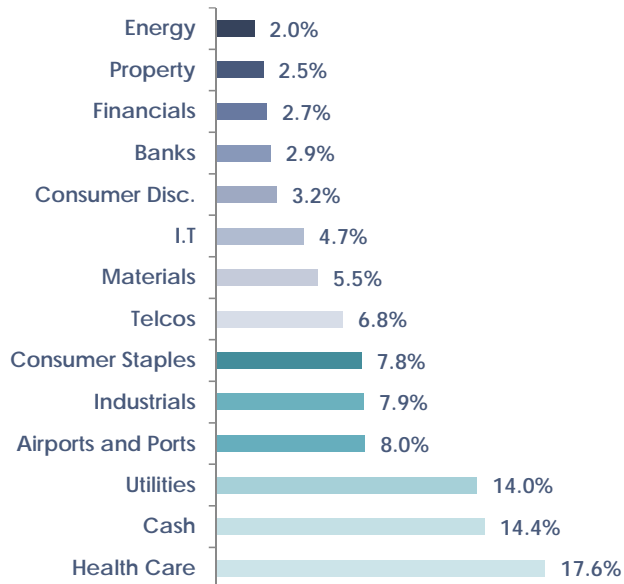

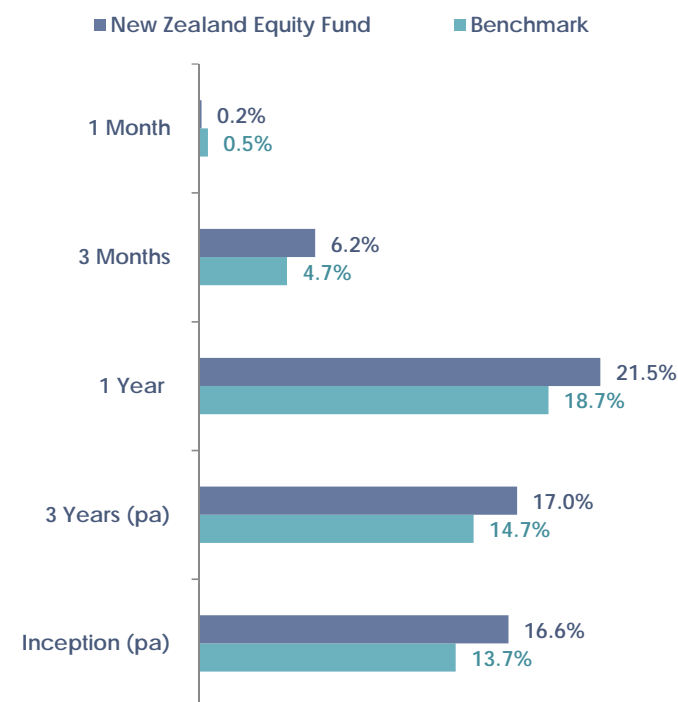

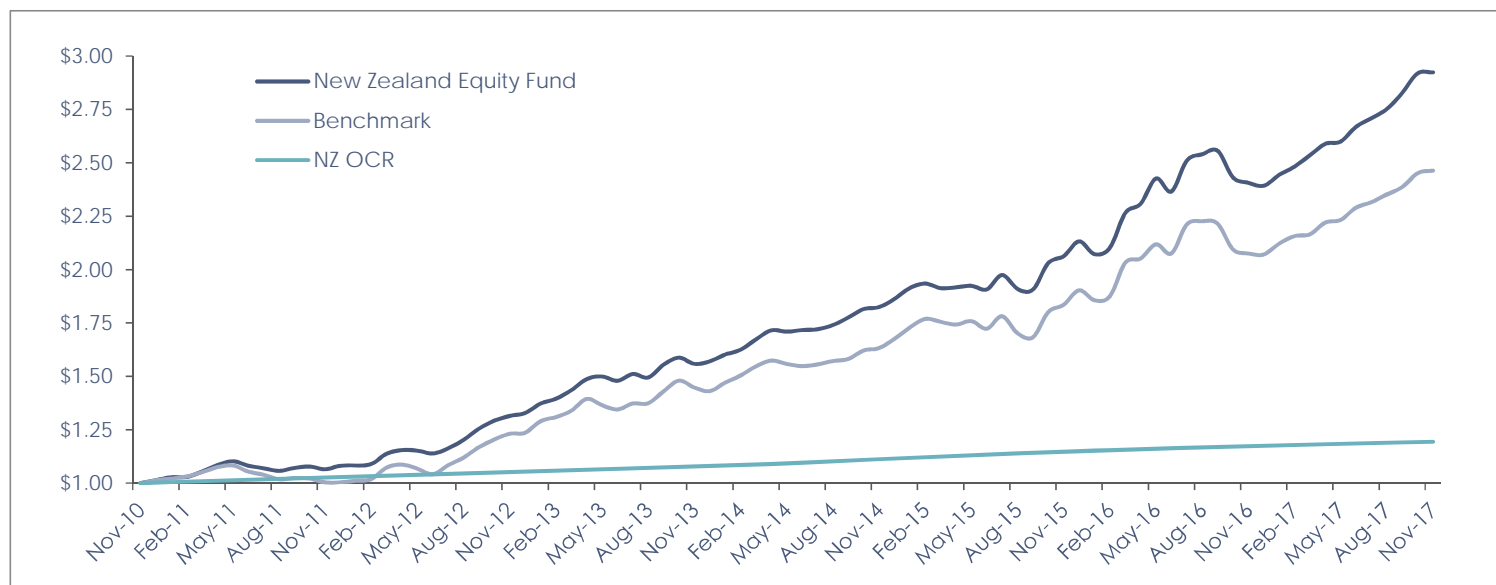
