## FUND DESCRIPTION

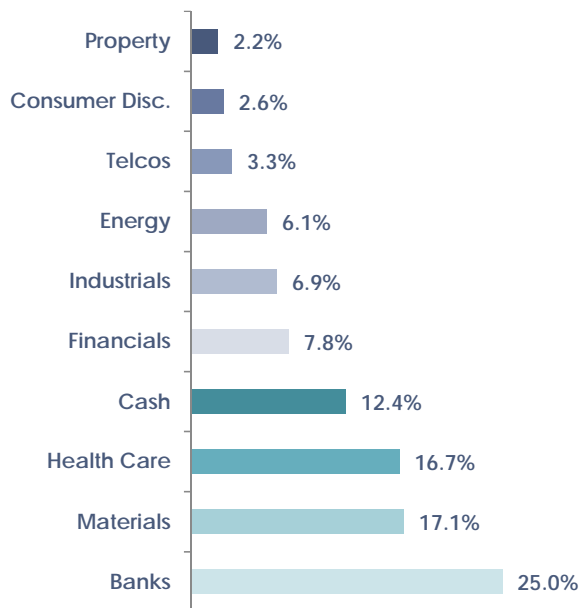

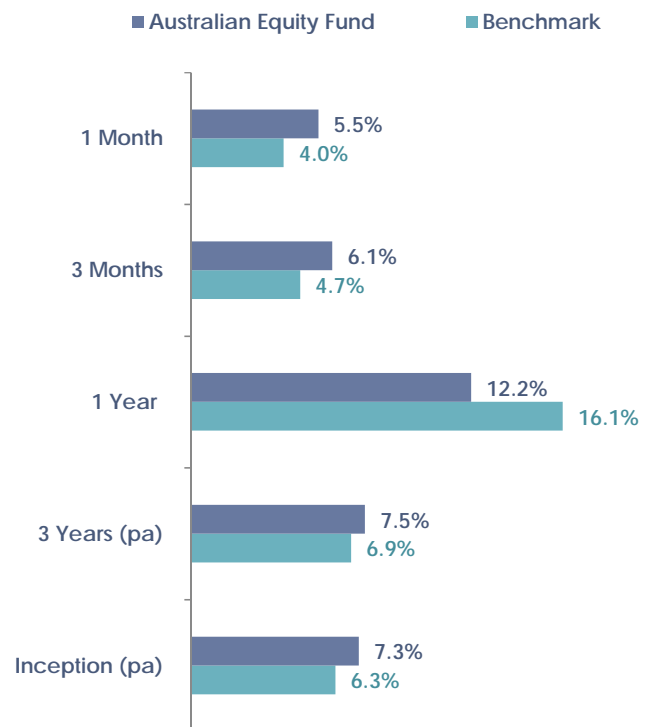

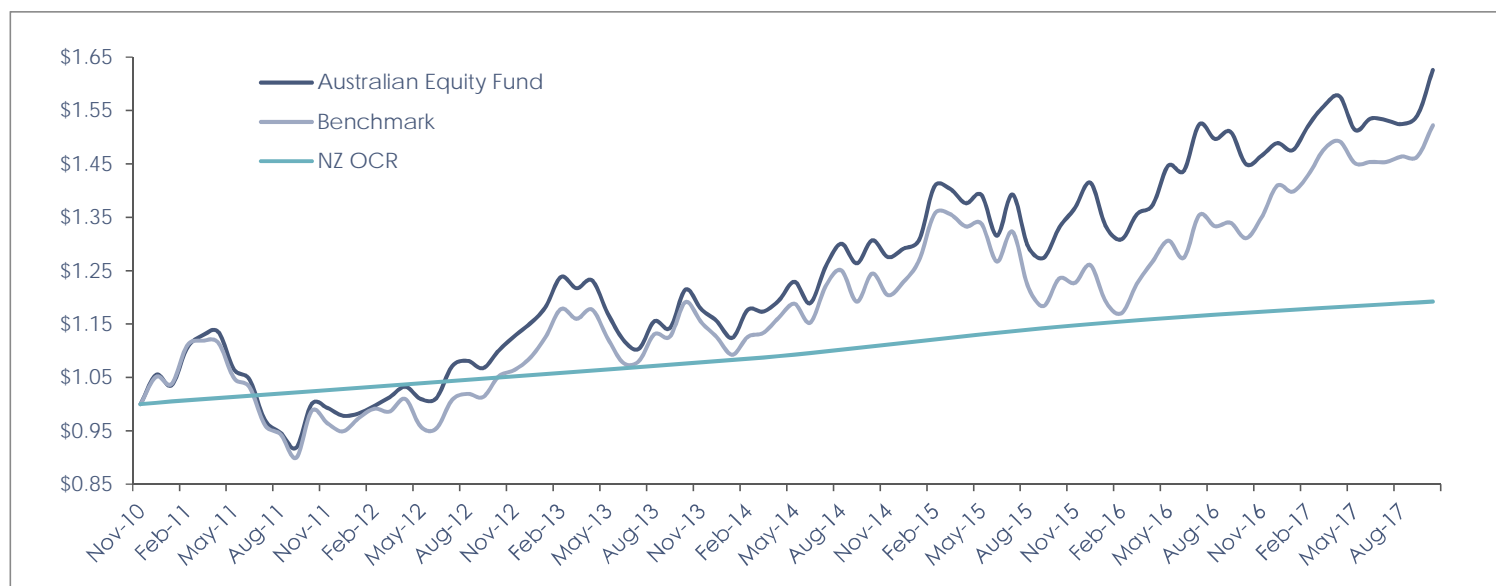
