## FUND DESCRIPTION

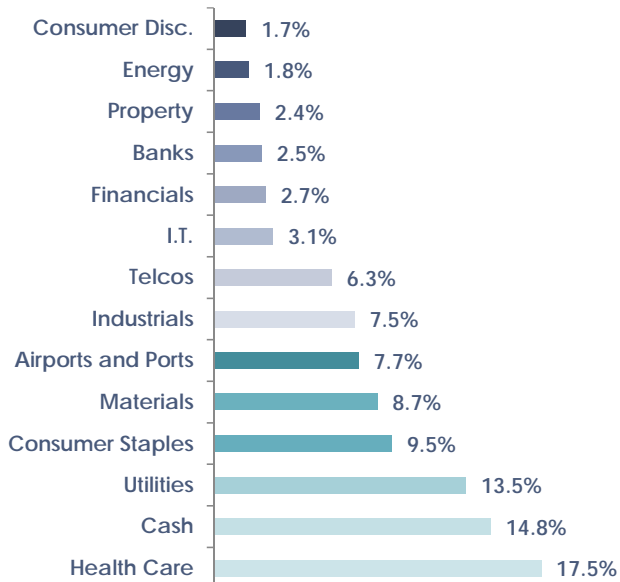

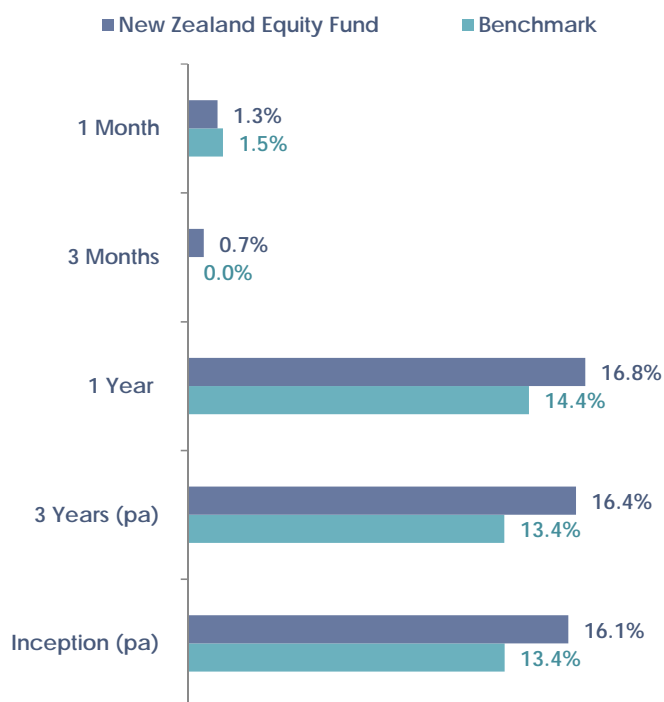

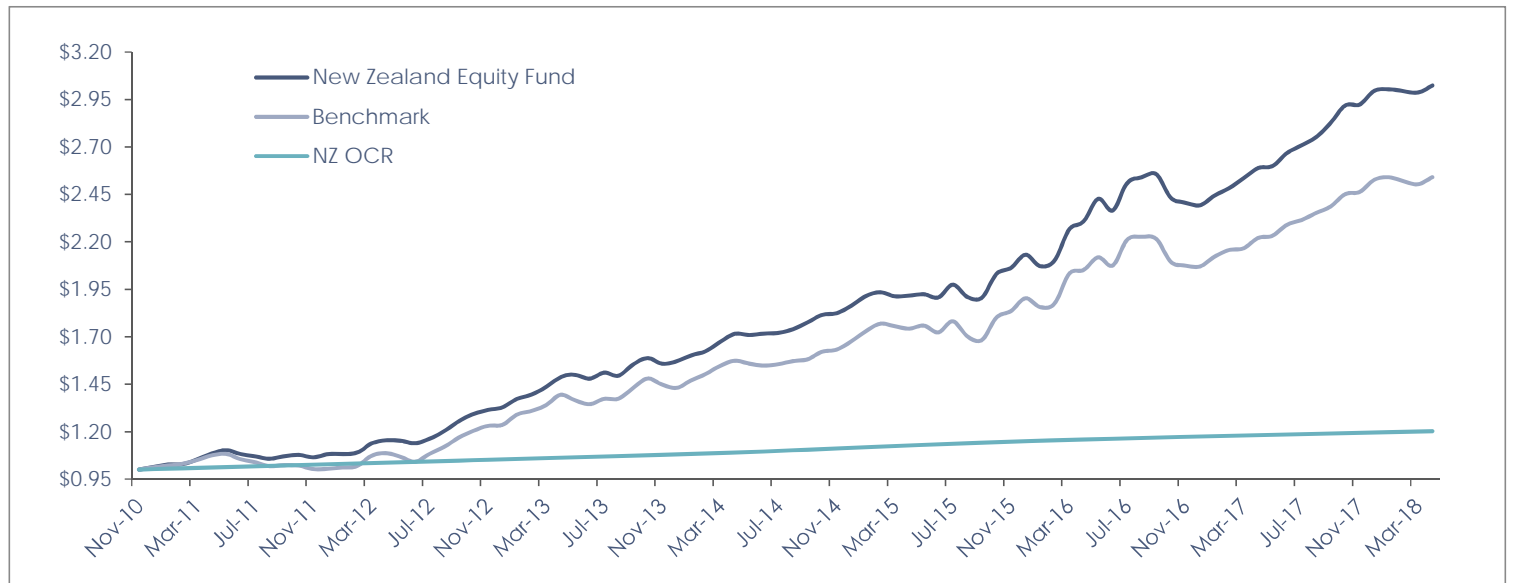
