## FUND DESCRIPTION

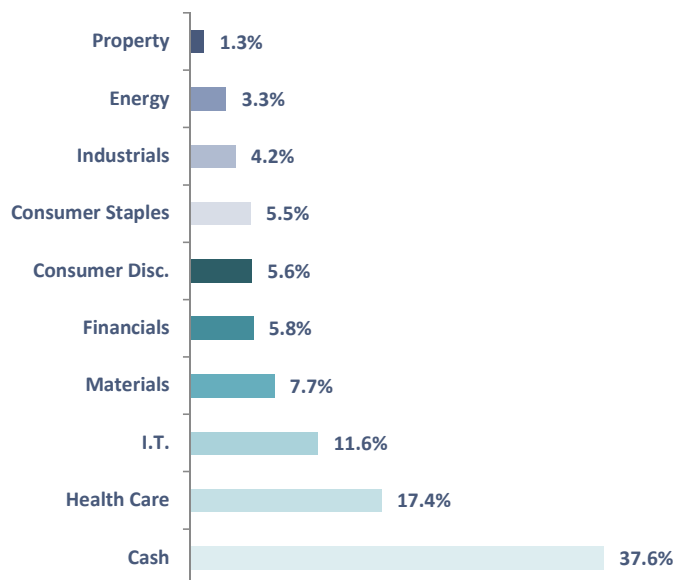

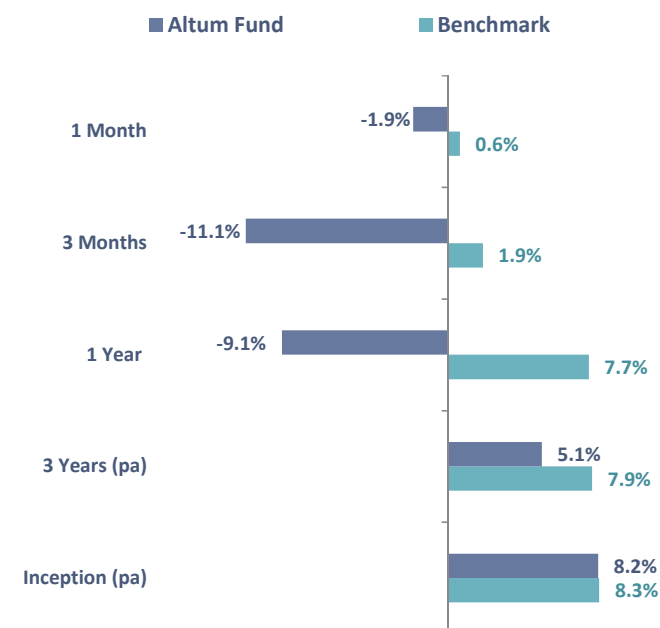
