## FUND DESCRIPTION

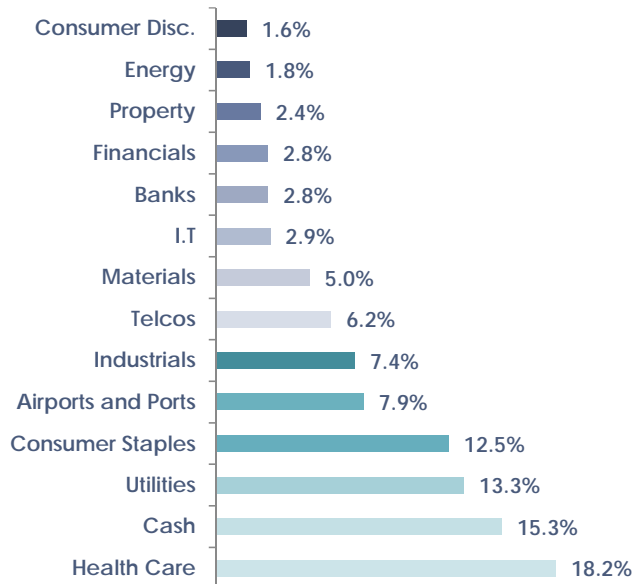

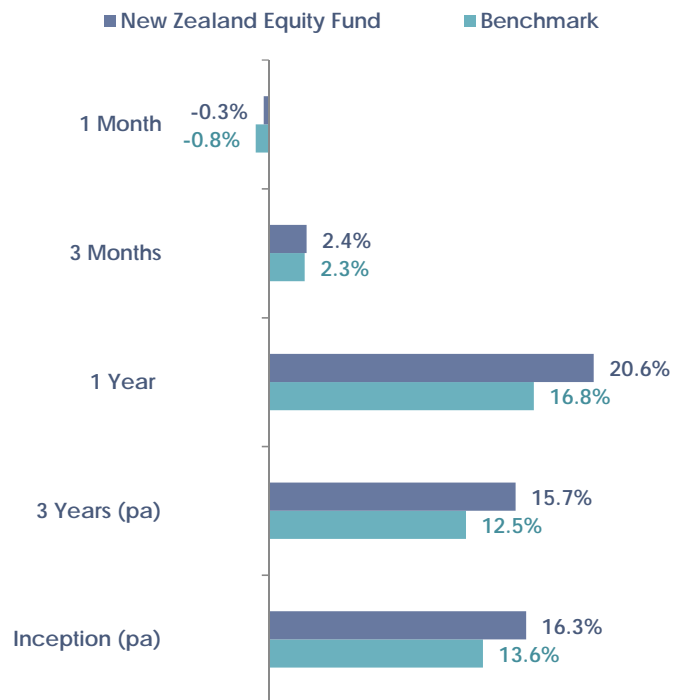

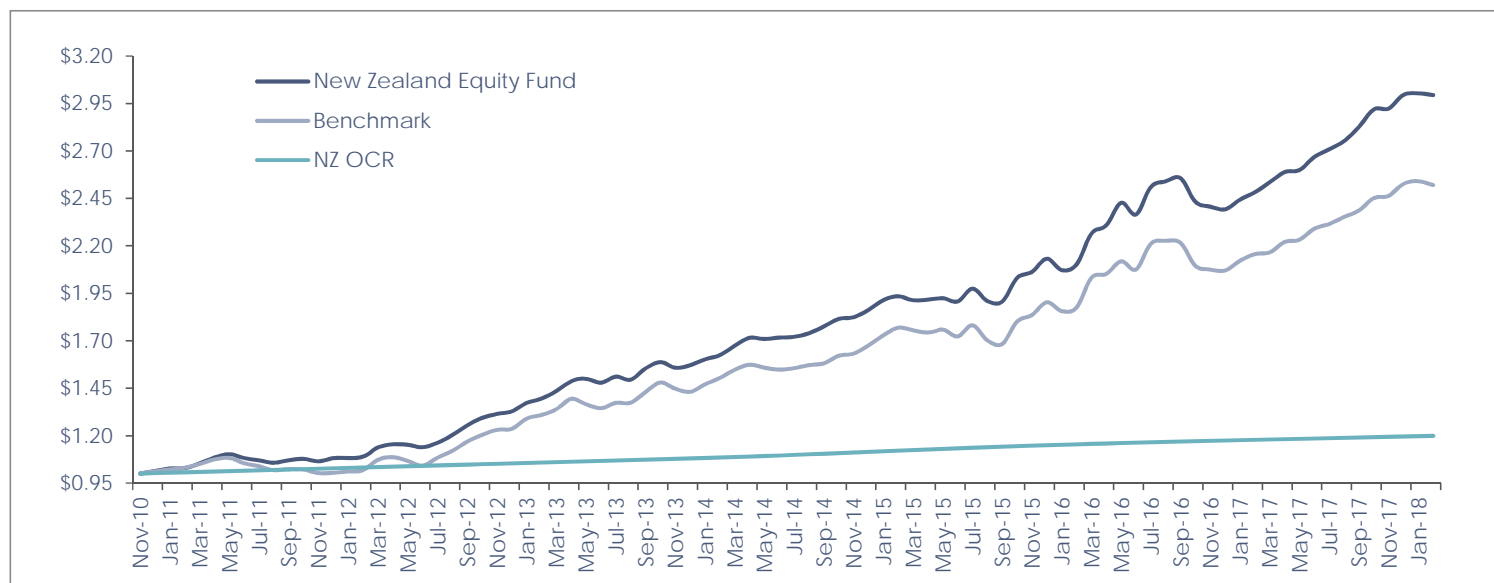
