## FUND DESCRIPTION

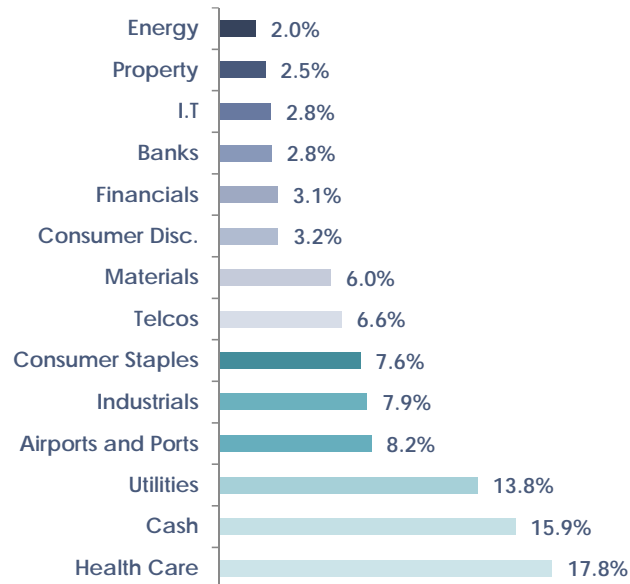

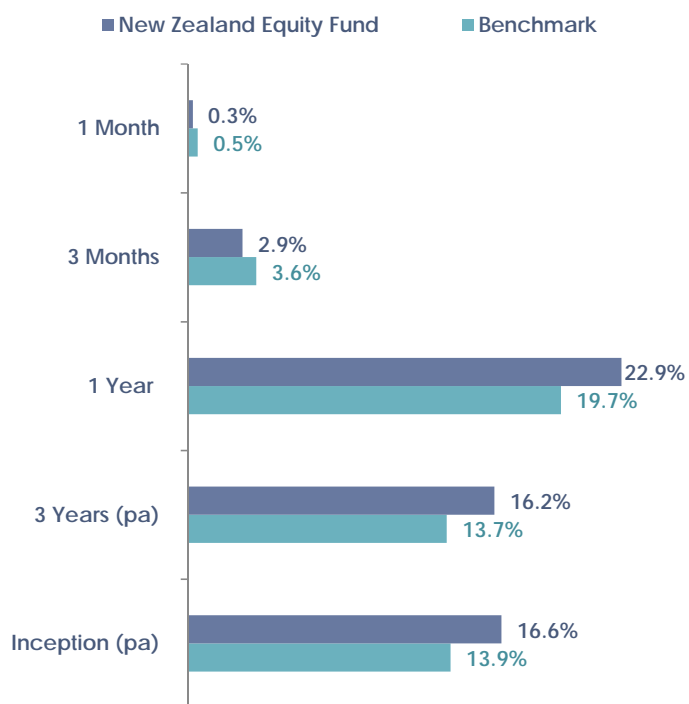

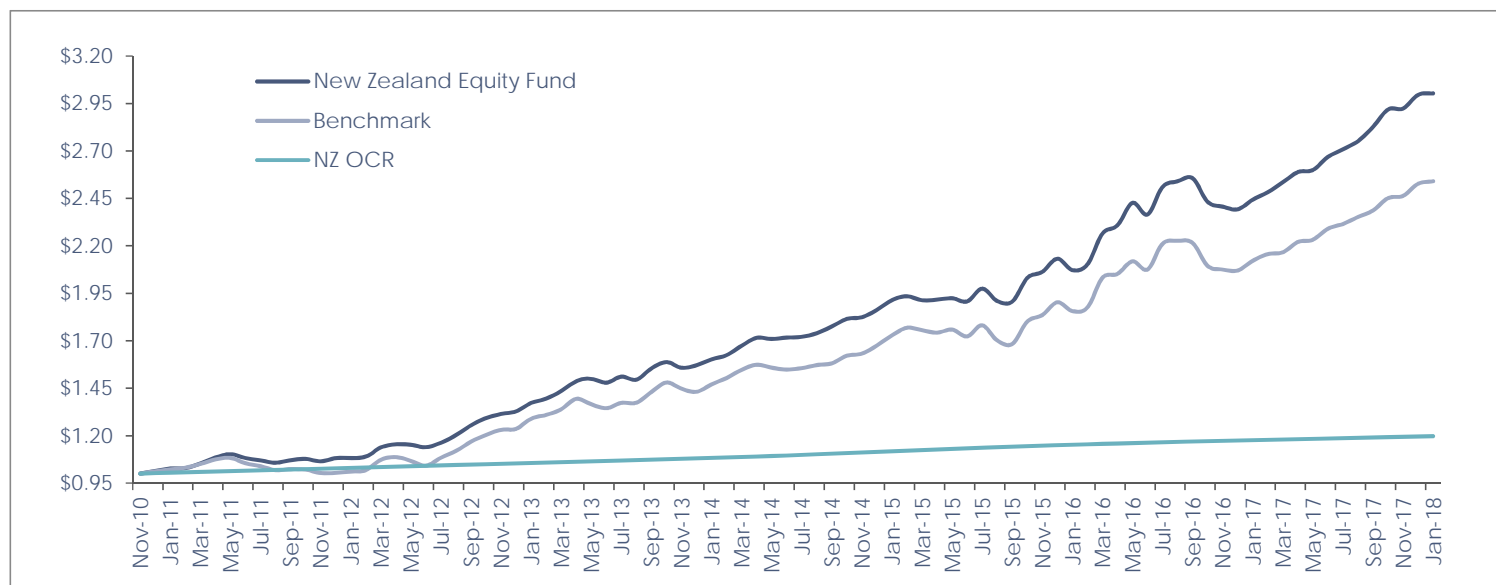
