FUND DESCRIPTION

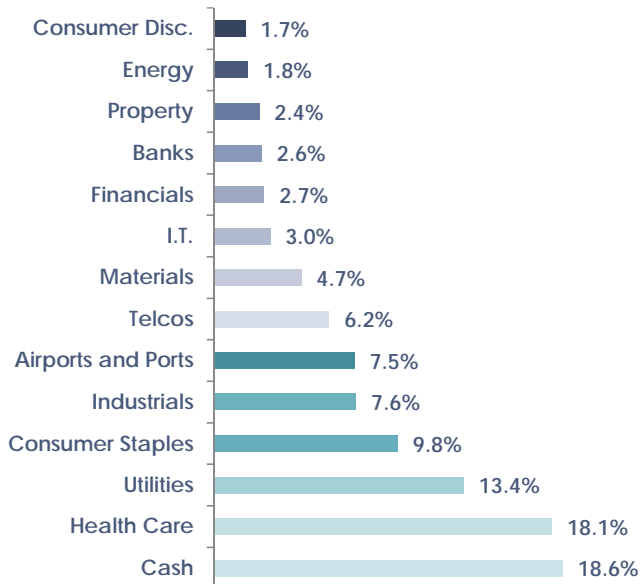

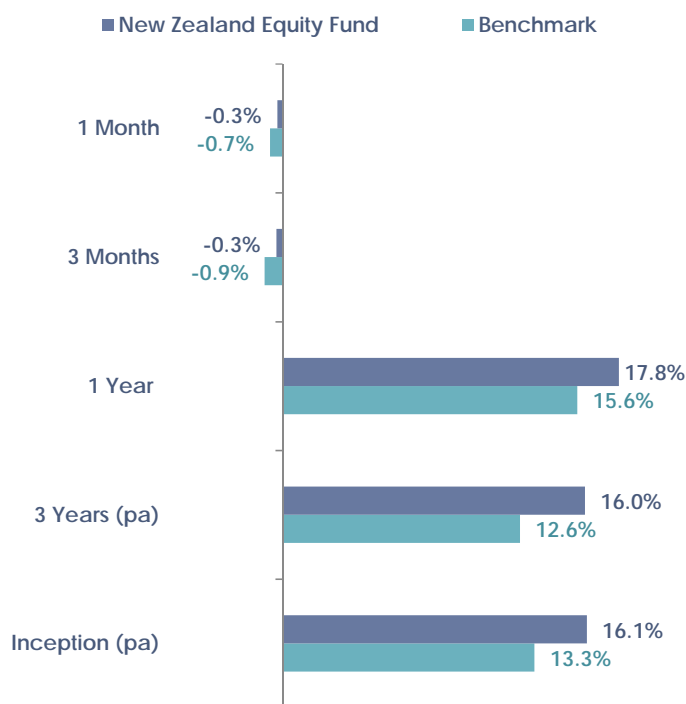

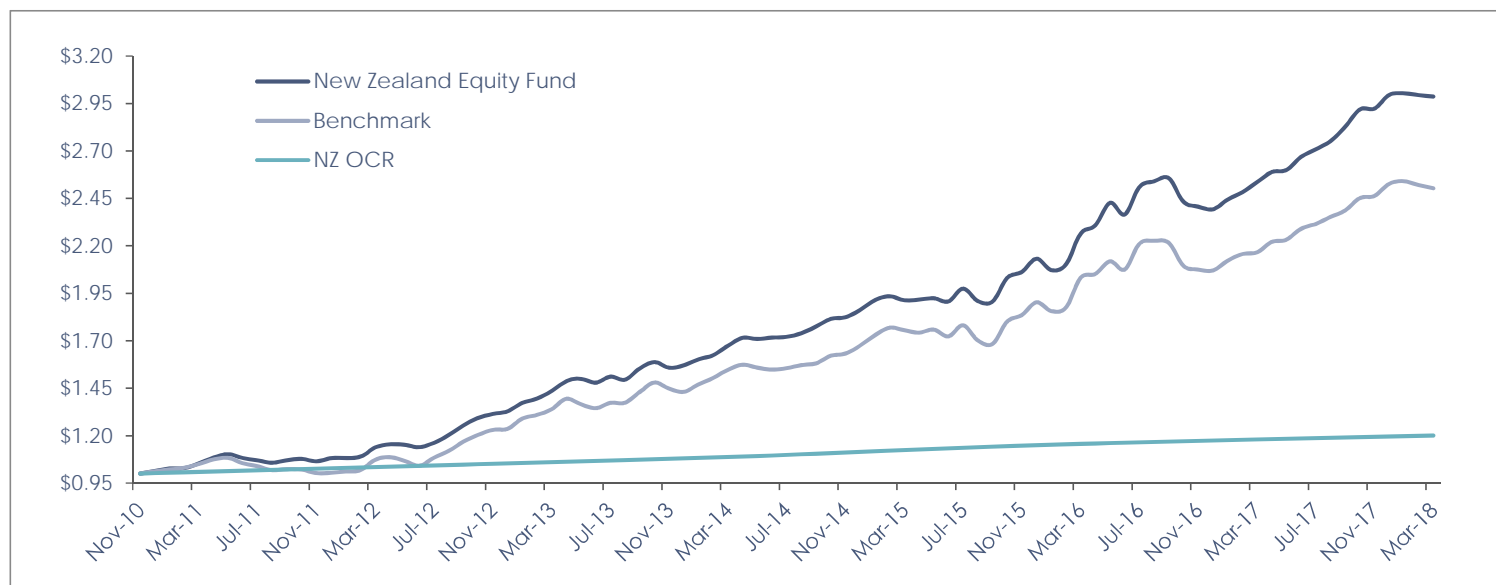
