

FUND DESCRIPTION


The QuayStreet Fixed Interest Fund invests in a diversified portfolio of high quality income assets such as cash, term deposits and securities issued by corporate and government entities. The investment objective is to provide investors with a level of return consistent with the New Zealand fixed interest market, above the Fund's benchmark return. Investment returns will vary from year to year and may be negative.


