FUND DESCRIPTION

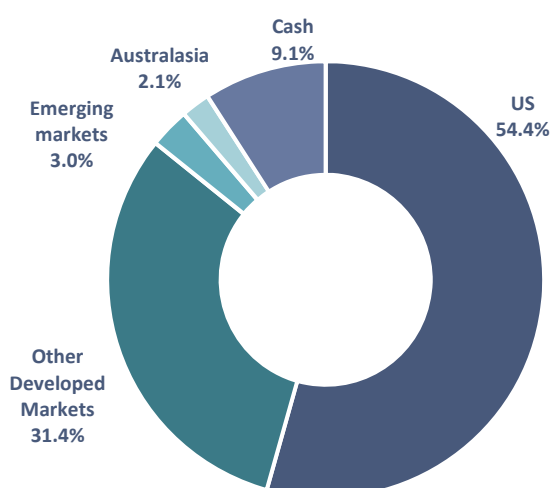

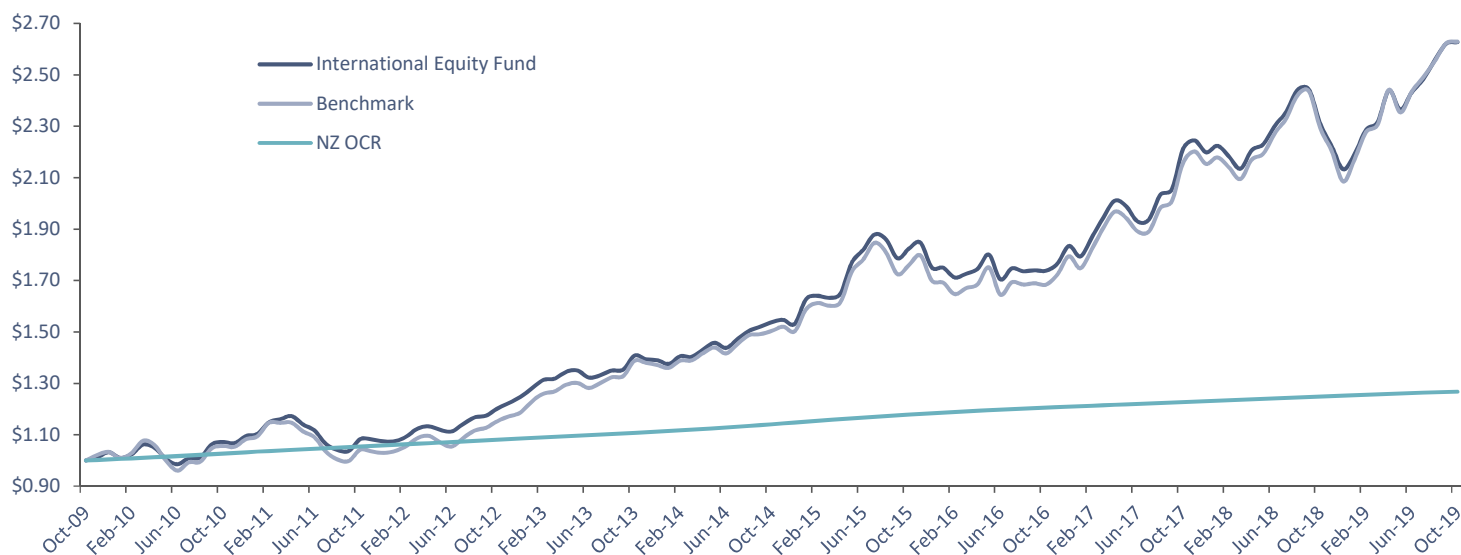
