FUND DESCRIPTION

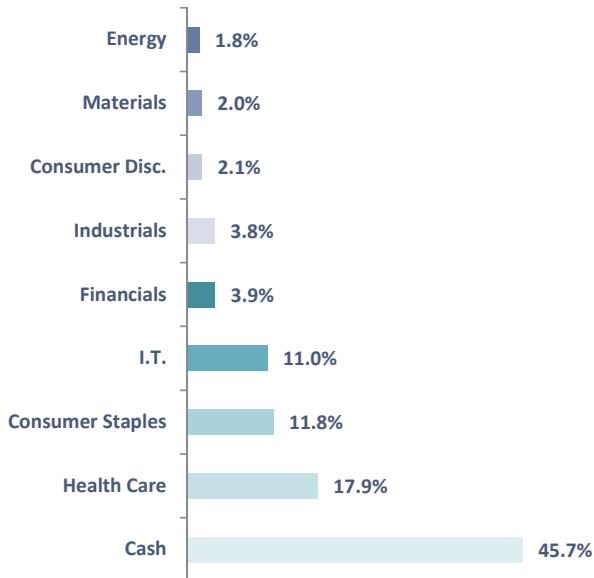

The investment objective is to provide investors with a level of return over the long term regardless of share market returns, above the performance benchmark. Investment returns will vary substantially from year to year and may be negative.

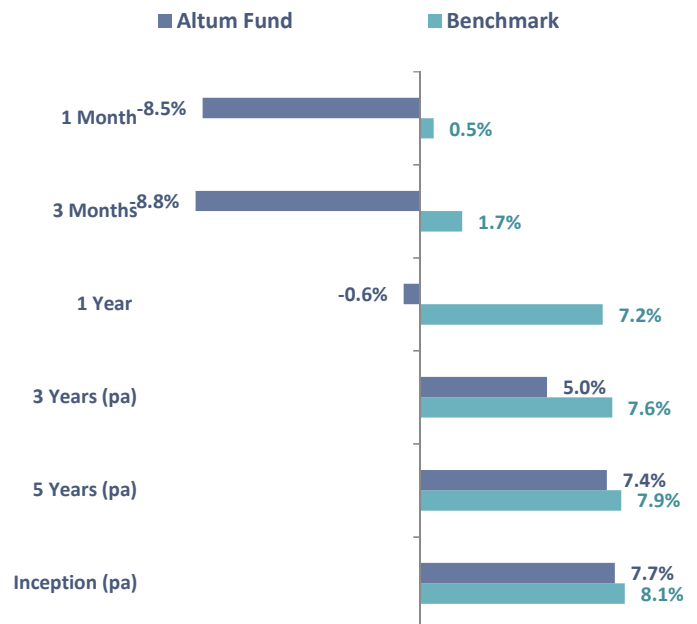
