FUND DESCRIPTION

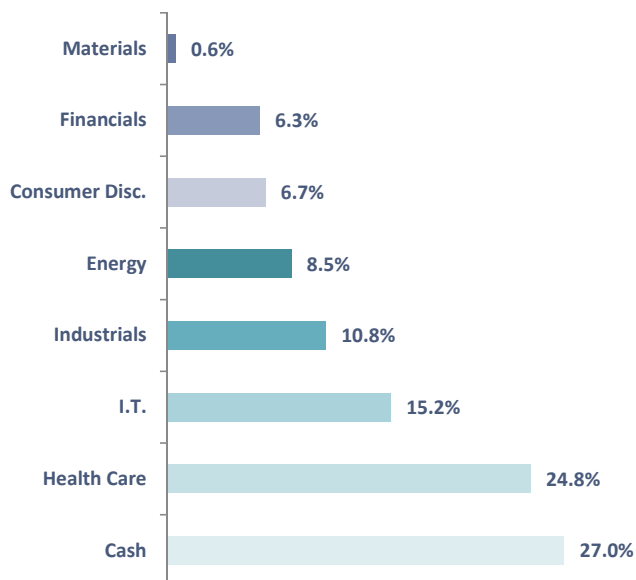

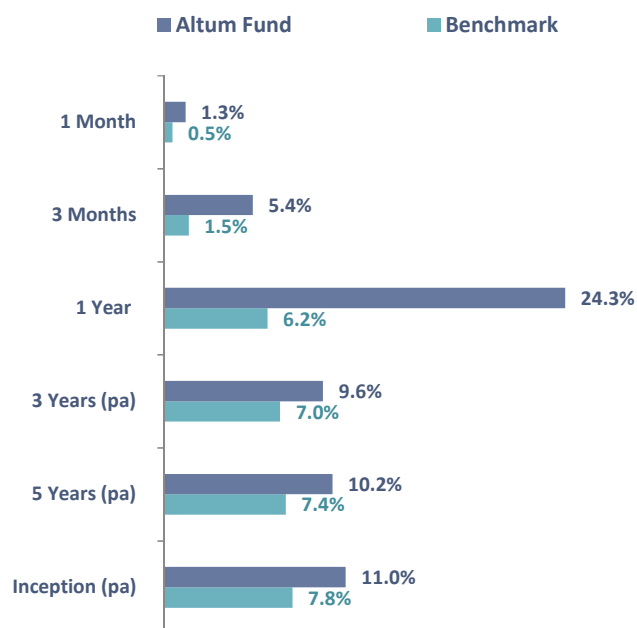
