## FUND DESCRIPTION

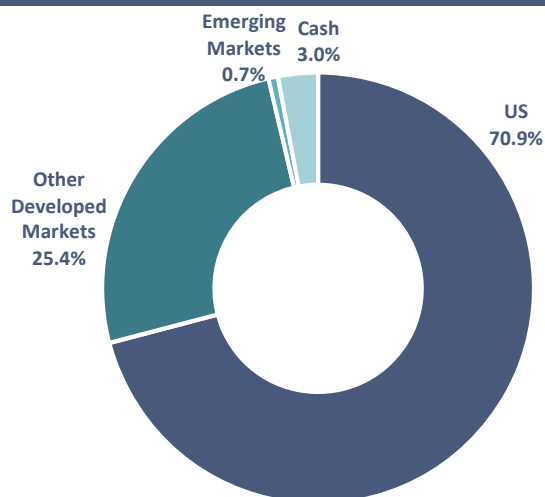

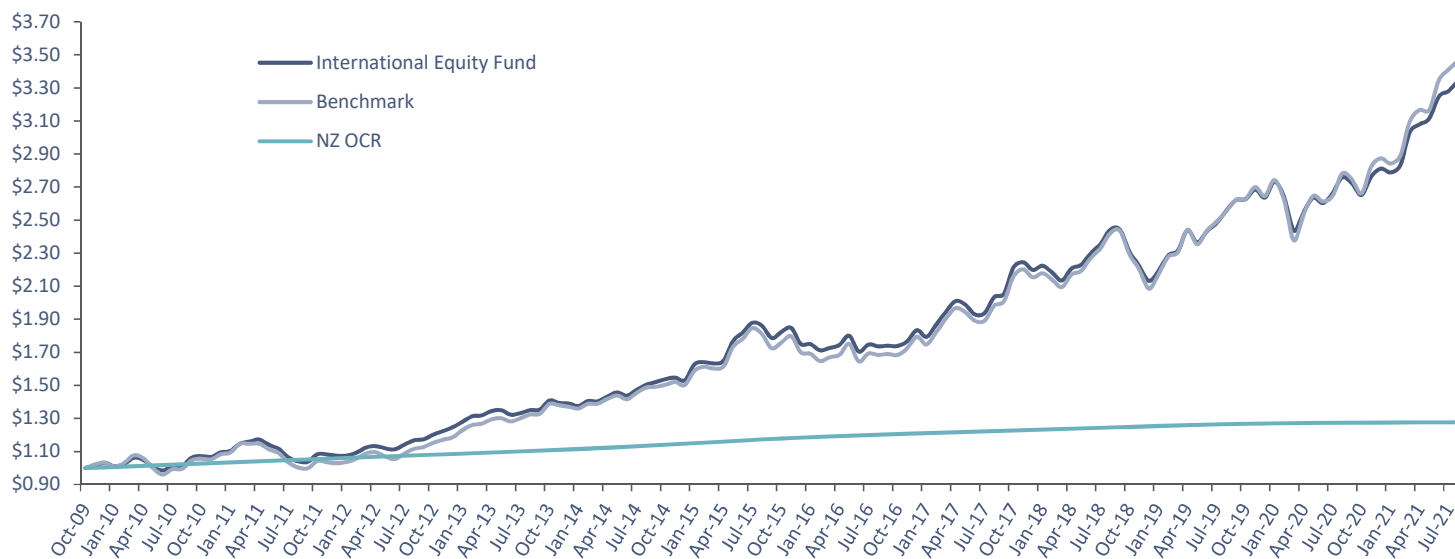
