This is a replacement fund update to replace the version dated 02 May 2017. Changes have been made to Section 4 'How has the fund performed' to the market indices figures. This fund update was first made publicly available on 05 May 2017.

1. WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the QuayStreet Conservative Fund (Conservative Fund) has performed and what fees were charged. The document will help you to compare the Fund with other funds. QuayStreet Asset Management Limited has prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

2. DESCRIPTION OF THIS FUND

A diversified portfolio, with an emphasis on fixed interest investments and less exposure to growth assets, targeting a return above the Fund's benchmark return.

3. WHAT ARE THE RISKS OF INVESTING?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

RISK INDICATOR FOR THE CONSERVATIVE FUND

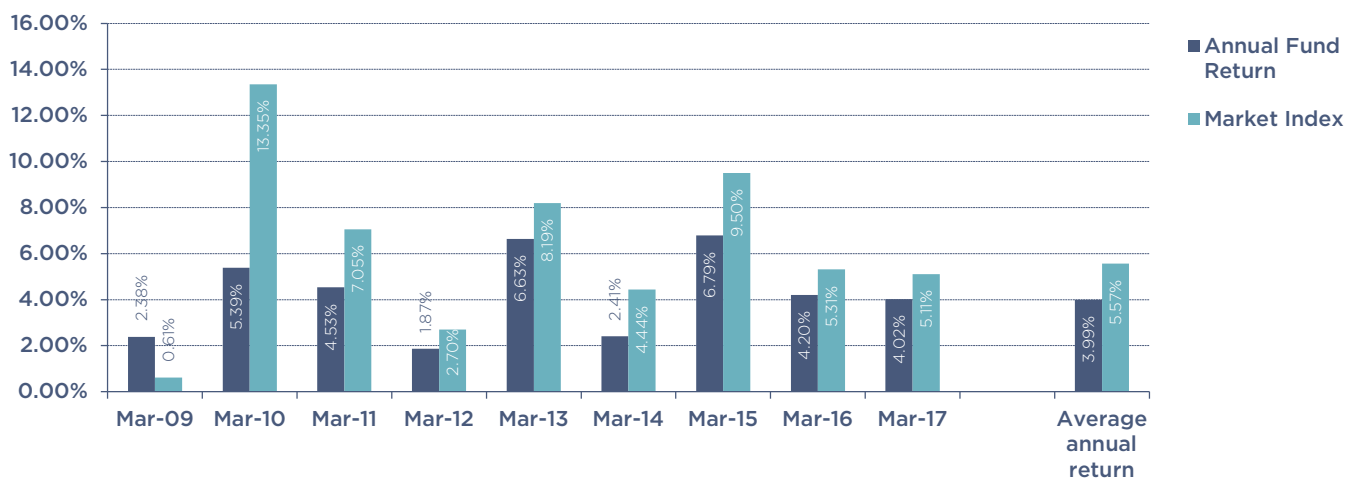

Brokerage

Up to 0.50% of the amount being traded when the Fund buys or sells securities.

Small difference in fees and charges can have a big impact on your investment over the long term.

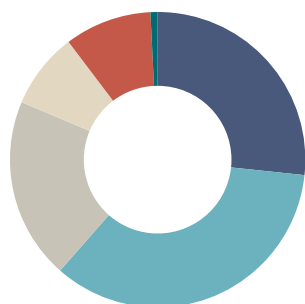
EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Emma has \$50,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Emma received a return after fund charges were deducted of \$2,530.00 (that is 5.06% of her initial \$50,000). Emma did not pay any other charges. This gives Emma a total return after tax of \$2,010.00 for the year.
