1. WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the QuayStreet Fixed Interest Fund (Fixed Interest Fund) has performed and what fees were charged. The document will help you to compare the Fund with other funds. QuayStreet Asset Management Limited has prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

2. DESCRIPTION OF THIS FUND

A diversified portfolio of fixed interest and derivatives investments targeting a return above the New Zealand retail 1 year term deposit interest rates.

3. WHAT ARE THE RISKS OF INVESTING?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

RISK INDICATOR FOR THE FIXED INTEREST FUND

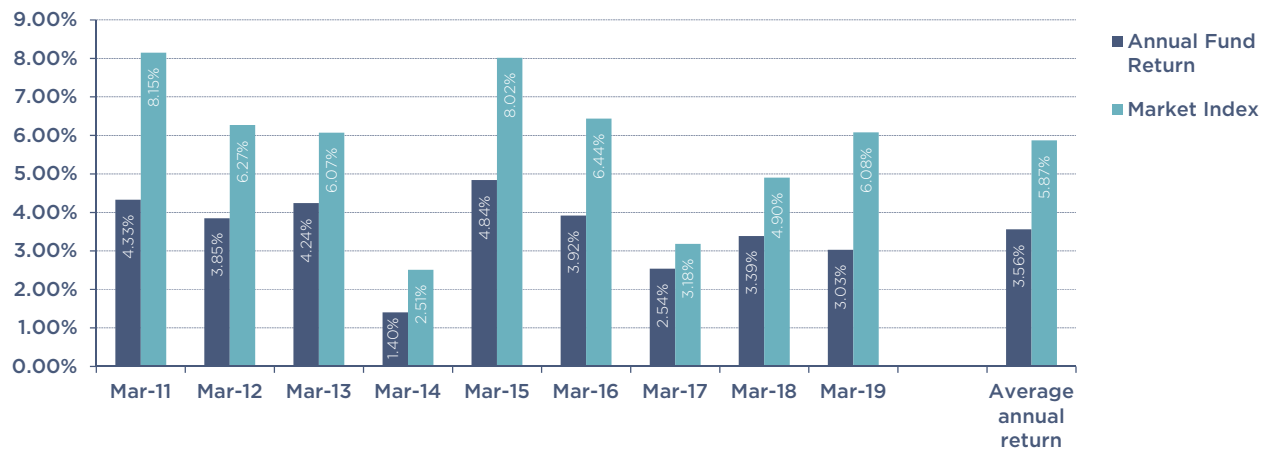

The above graph shows the return after fund charges and tax for each full year ending 31 March since the Fund started. The last bar shows the average annual return since the Fund started, up to 31 March 2019.

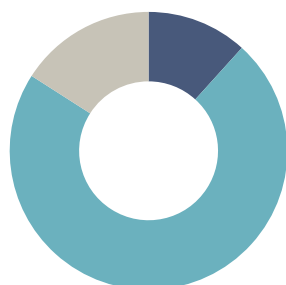
EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Emma has \$50,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Emma received a return after fund charges were deducted of \$2,120.00 (that is 4.24% of her initial \$50,000). Emma did not pay any other charges. This gives Emma a total return after tax of \$1,515.00 for the year.
