This is a replacement fund update to replace the version dated 27 January 2017 which was first made publicly available on 16 February 2017. Changes have been made to Section 4 'How has the fund performed' to the table and Annual return graph and to Section 6 "What does the Fund invest in" Top 10 Investments to include the Credit rating. This replacement Fund Update was first made publicly available on 19 August 2020.

1. WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the QuayStreet Income Fund (Income Fund) has performed and what fees were charged. The document will help you to compare the Fund with other funds. QuayStreet Asset Management Limited has prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

2. DESCRIPTION OF THIS FUND

A diversified portfolio of income producing assets that can include listed property and equities targeting a return above prevailing short term retail interest rates while preserving the real value of investments relative to inflation.

3. WHAT ARE THE RISKS OF INVESTING?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

RISK INDICATOR FOR THE INCOME FUND¹



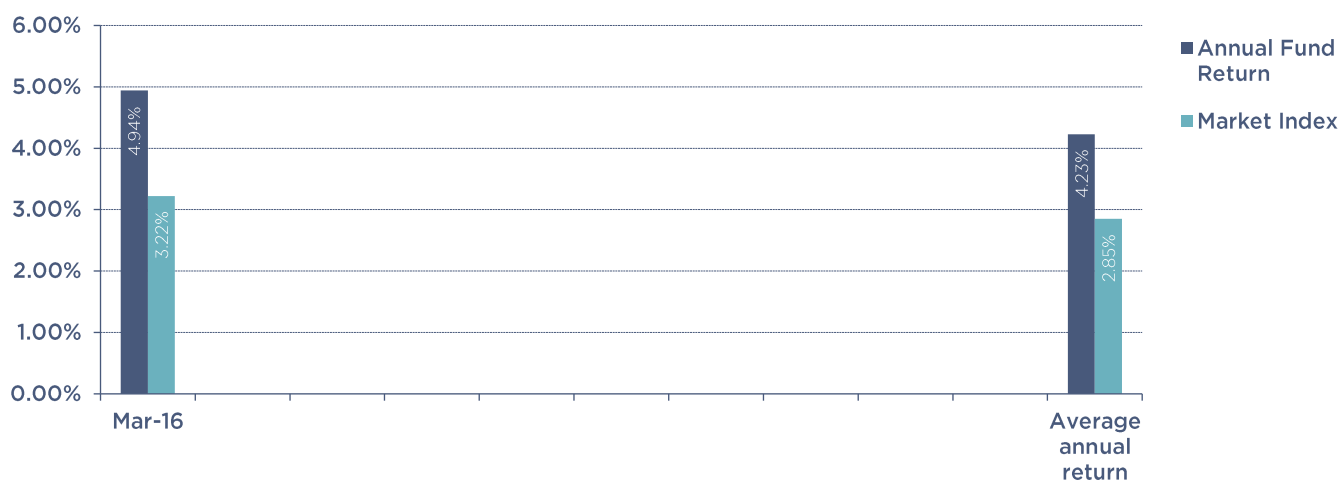
4. HOW HAS THE FUND PERFORMED?

ANNUAL RETURN GRAPH²



This shows the return after fund charges and tax for each full year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 December 2016.

DESCRIPTION OF HOW CHARGE IS CALCULATED

Administration Fee	Up to \$30.00 per annum per member charged to your member account in September and March.
Scheme Expenses*	Approximately \$16.40 per annum per member. This estimate has been based on the total amount of costs and expenses recovered during the Scheme's previous financial year on a per member basis. The actual expenses incurred will vary from time to time and are recovered on a per member basis.

* Scheme expenses are significantly impacted by the costs of transitioning to the Financial Markets Conduct Act 2013.

6. EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

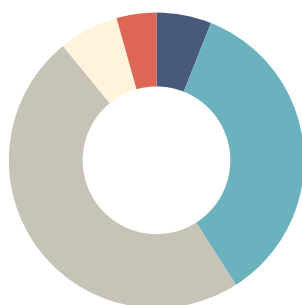
Small differences in fees and charges can have a big impact on your investment over the long term.

Emma has \$50,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Emma received a return after fund charges were deducted of \$2,555.00 (that is 5.11% of her initial \$50,000). Emma paid \$46.40 in other charges. This gives Emma a total return after tax of \$1,818.60 for the year.
