This is a replacement fund update to replace the version dated 02 May 2017. Changes have been made to Section 4 'How has the fund performed' to the market indices figures. This fund update was first made publicly available on 05 May 2017.

1. WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the QuayStreet Balanced Fund (Balanced Fund) has performed and what fees were charged. The document will help you to compare the Fund with other funds. QuayStreet Asset Management Limited has prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

2. DESCRIPTION OF THIS FUND

A diversified portfolio with a balance between income and growth assets targeting a return above the Fund's benchmark return.

3. WHAT ARE THE RISKS OF INVESTING?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

RISK INDICATOR FOR THE BALANCED FUND

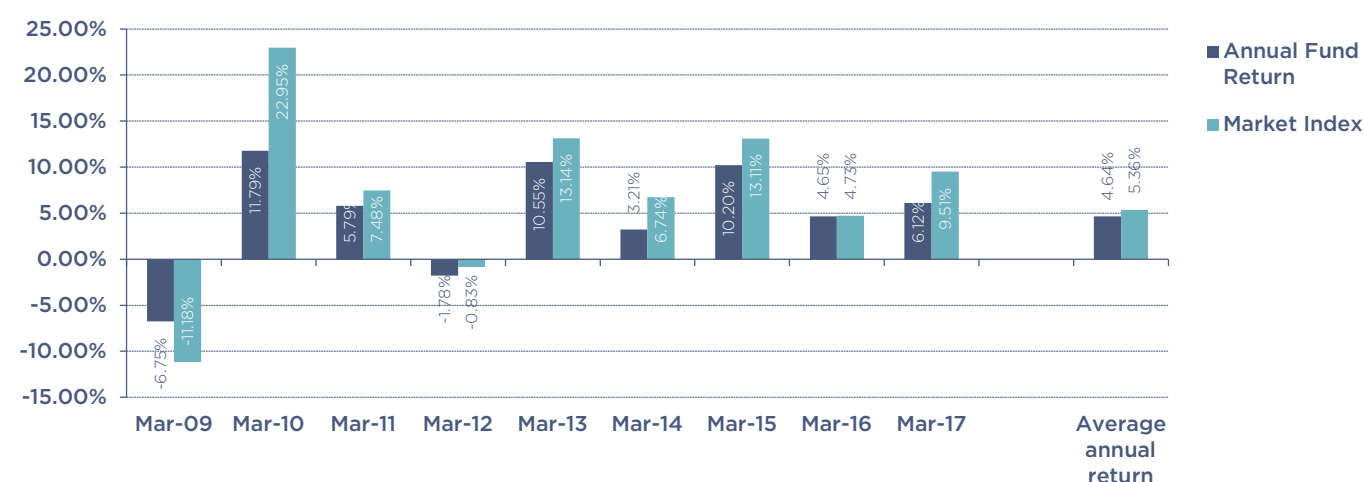

DESCRIPTION OF HOW CHARGE IS CALCUCATED

Administration Fee	Up to \$30.00 per annum per member charged to your member account in September and March.
Scheme Expenses*	Approximately \$15.58 per annum per member. This estimate has been based on the total amount of costs and expenses recovered during the Scheme's previous financial year on a per member basis. The actual expenses incurred will vary from time to time and are recovered on a per member basis.

* Scheme expenses are significantly impacted by the costs of transitioning to the Financial Markets Conduct Act 2013.

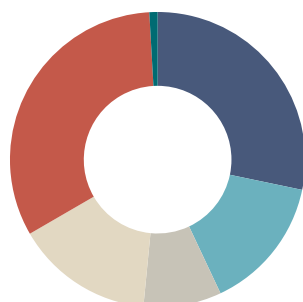
EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Emma has \$50,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Emma received a return after fund charges were deducted of \$3,585.00.00 (that is 7.17% of her initial \$50,000). Emma also paid \$45.58 in other charges. This gives Emma a total return after tax of \$3,014.42 for the year.
