This fund update was first made publicly available on 24 October 2019.

1. WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the QuayStreet Altum Fund (Altum Fund) has performed and what fees were charged. The document will help you to compare the Fund with other funds. QuayStreet Asset Management Limited has prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

2. DESCRIPTION OF THIS FUND

A concentrated portfolio of shares from Australia and New Zealand which can at times include cash and fixed interest investments and derivatives, targeting a long-term return above the New Zealand Official Cash Rate regardless of share market returns.

3. WHAT ARE THE RISKS OF INVESTING?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

RISK INDICATOR FOR THE ALTUM FUND¹



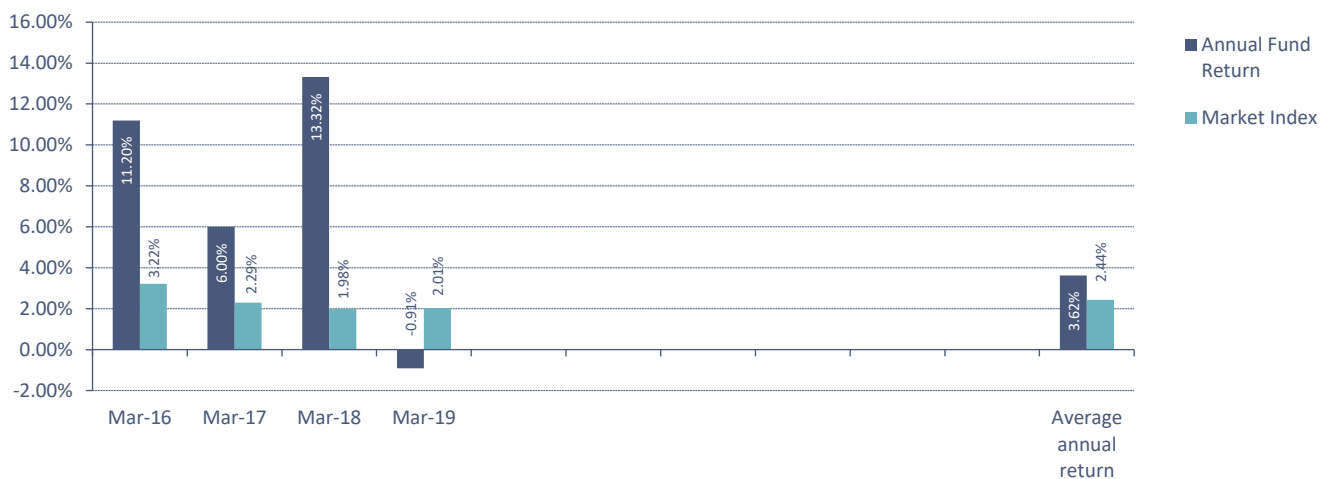
4. HOW HAS THE FUND PERFORMED?

OTHER CHARGES	DESCRIPTION OF HOW CHARGE IS CALCULATED
Administration Fee	Up to \$30.00 per annum per member charged to your member account in September and March.
Scheme Expenses	Approximately \$10.04 per annum per member. This estimate has been based on the total amount of costs and expenses recovered during the Scheme's previous financial year on a per member basis. The actual expenses incurred will vary from time to time and are recovered on a per member basis.

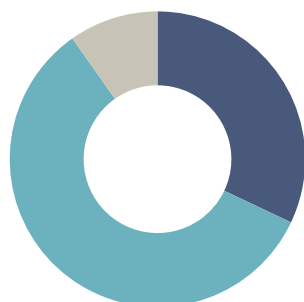
EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Emma has \$50,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Emma received a return after fund charges were deducted of \$(845.00) (that is -1.69% of her initial \$50,000). Emma also paid \$40.04 in other charges. This gives Emma a total return after tax of \$(1,130.04) for the year.

¹ The QuayStreet Altum Fund commenced operation on 30 September 2014. The risk indicator for this Fund is based on a combination of actual fund returns and market index returns, with market index returns being used for the period prior to 30 September 2014. Therefore the risk indicator may be a less reliable indicator of the potential future volatility of these Funds

² The benchmark return for performance fee calculations is not the NZ 90 day Bank Bill Index. The performance fee calculation uses the NZ OCR + 6%.

³ Market Index returns do not reflect deductions of any fees or taxes.

⁴ Management fees in the QuayStreet Altum Fund of 1.25% include Supervisor, Custody and Registry charges which are shown here as other management and administration charges. Other management and administration charges also include expenses incurred within the Fund. This percentage will change from year to year.

⁵ A performance fee was not charged in the year ended 31 March 2019. The performance fee is calculated as an average of the last four years fees since inception of the fund.
