1. WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the QuayStreet International Equity Fund (International Equity Fund) has performed and what fees were charged. The document will help you to compare the Fund with other funds. QuayStreet Asset Management Limited has prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

2. DESCRIPTION OF THIS FUND

An exposure to international equity markets diversifying investors away from New Zealand dollar exposures targeting a return above the performance of international share markets.

3. WHAT ARE THE RISKS OF INVESTING?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

RISK INDICATOR FOR THE INTERNATIONAL EQUITY FUND¹

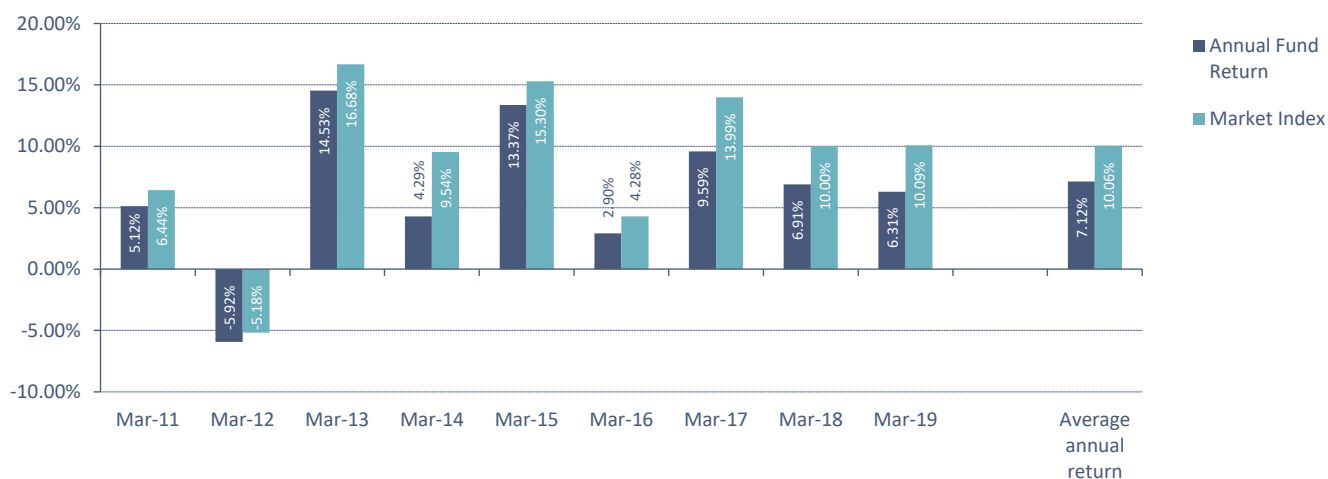

Administration Fee	Up to \$30.00 per annum per member charged to your member account in September and March.

The actual expenses incurred will vary from time to time and are recovered on a per member basis.

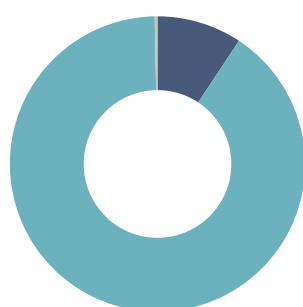
EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Emma has \$50,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Emma incurred a return after fund charges were deducted of \$2,975.00 (that is 5.95% of her initial \$50,000). Emma paid \$40.04 in other charges. This gives Emma a total return after tax of \$2,369.96 for the year.

The top 10 investments make up 95.18% of the gross asset value (adding back the value of liabilities relating to derivatives investments such as currency hedges and Total Return Swaps).

CURRENCY HEDGING

The Fund's foreign currency exposure is actively managed in a manner consistent with the investment objectives and the performance benchmark. The current exposure to foreign currencies is 100% compared to the benchmark foreign currency exposure of 100%.
