## QuayStreet Australian Equity Fund

### 1. WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the QuayStreet Australian Equity Fund (Australian Equity Fund) has performed and what fees were charged. The document will help you to compare the Fund with other funds. QuayStreet Asset Management Limited has prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### 2. DESCRIPTION OF THIS FUND

A portfolio of shares from Australia targeting a return above the long term performance of the Australian share market.

### 3. WHAT ARE THE RISKS OF INVESTING?

#### RISK INDICATOR FOR THE AUSTRALIAN EQUITY FUND

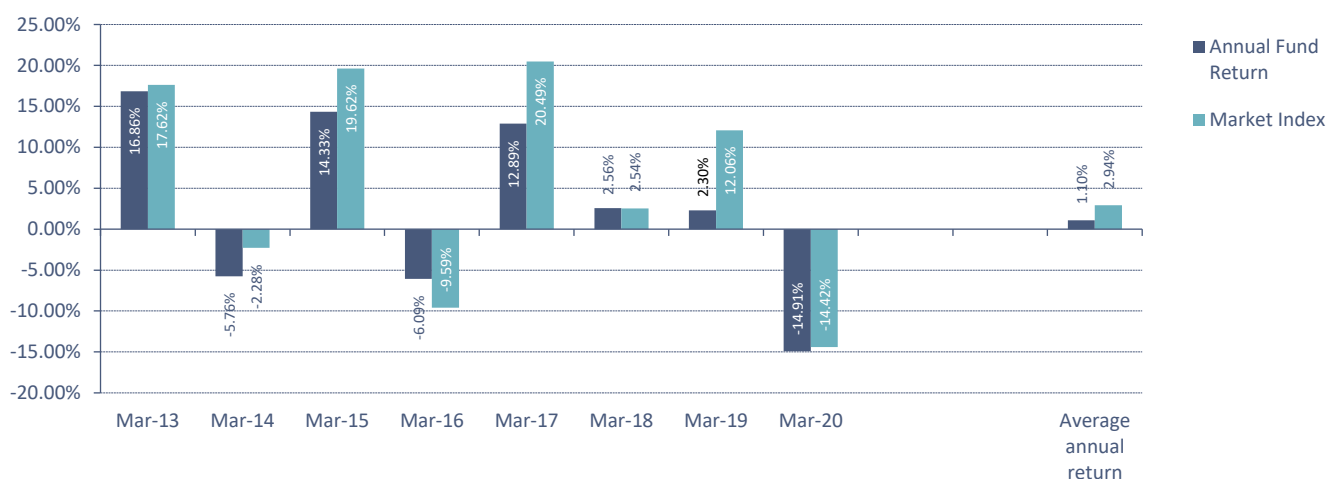

## 5. WHAT FEES ARE INVESTORS CHARGED?

Investors in the QuayStreet Australian Equity Fund are charged fund charges. In the year to 31 March 2020 these were:

Administration Fee	Up to \$30.00 per annum per member charged to your member account in September and March.

This estimate has been based on the total amount of costs and expenses recovered during the Scheme's previous financial year on a per member basis. The actual expenses incurred will vary from time to time and are recovered on a per member basis.

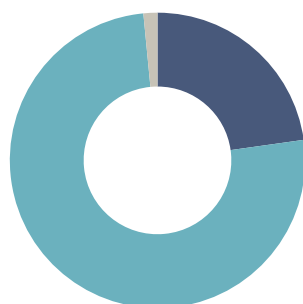
### EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Emma had \$50,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Emma incurred a loss after fund charges were deducted of \$7,160.00 (that is -14.32% of her initial \$50,000). Emma also paid \$35.49 in other charges. This gives Emma a total loss after tax of \$7,490.49 for the year.
