1. WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the QuayStreet Growth Fund (Growth Fund) has performed and what fees were charged. The document will help you to compare the Fund with other funds. QuayStreet Asset Management Limited has prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

2. DESCRIPTION OF THIS FUND

A diversified portfolio with an emphasis on growth assets, targeting a return above the Fund's benchmark return.

3. WHAT ARE THE RISKS OF INVESTING?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

RISK INDICATOR FOR THE GROWTH FUND

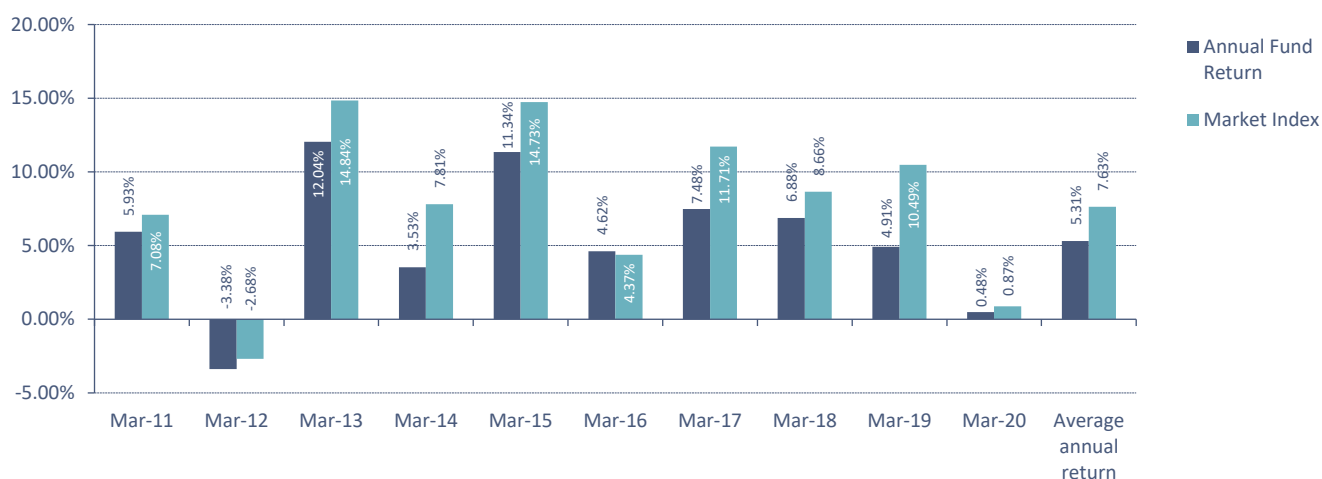

OTHER CHARGES

DESCRIPTION OF HOW CHARGE IS CALCULATED

Administration Fee	Up to \$30.00 per annum per member charged to your member account in September and March.
Scheme Expenses	Approximately \$5.49 per annum per member. This estimate has been based on the total amount of costs and expenses recovered during the Scheme's previous financial year on a per member basis. The actual expenses incurred will vary from time to time and are recovered on a per member basis.

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). See the PDS for the QuayStreet KiwiSaver Scheme for more information about those fees.

The QuayStreet Growth Fund invests in the QuayStreet Altum Fund which is managed by QuayStreet Asset Management Limited ('the Manager'). The Manager is entitled to charge a performance fee in respect of investments in the QuayStreet Altum Fund, which is reflected above. See the PDS for more information about the basis on which performance fees are charged within the QuayStreet Altum Fund.

Small difference in fees and charges can have a big impact on your investment over the long term.

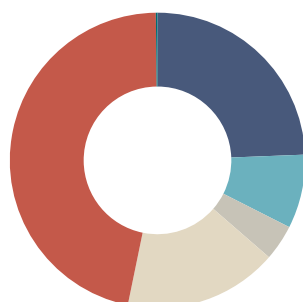
EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Emma had \$50,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Emma received a return after fund charges were deducted of \$435.00 (that is 0.87% of her initial \$50,000). Emma paid \$35.49 in other charges. This gives Emma a total return after tax of \$204.51 for the year.

The Fund's foreign currency exposure is actively managed in a manner consistent with the investment objectives and the performance benchmark. The current exposure to foreign currencies is 60% compared to the benchmark foreign currency exposure of 55%.
